- 1. 1.1 Definitions

  "Seller" shall mean The Reef Imaging Trust T/A Reef Imaging its successors and assigns or any person acting on behalf of and with the authority of The Reef Imaging Trust T/A Reef Imaging.

  "Buyer" shall mean the Buyer (or any person acting on behalf of and with the authority of the Buyer) as described on any quotation, work authorisation or other form as provided by the Seller to the Buyer.

  "Guarantor" means that person (or persons), or entity, who agrees to be liable for the debts of the Buyer on a retirected telephological.

  "Goods" shall mean Goods supplied by the Seller to the Buyer (and where the context so permits shall include any supply of Services as hereinafter defined) and are as described on the invoices, quotation, work authorisation or any other forms as provided by the Seller to the Buyer.
  "Services" shall mean all Services supplied by the Seller to the Buyer and includes any advice or recommendations (and where the context so permits shall include any supply of Goods as defined above).

- 2.3 Upon acceptance of these terms and conditions by the Buyer the terms and conditions are binding and can only

  shall accept the Seller's quotation in writing within thirty (30) days.

  The Seller reserves the right to change the Price in the event of a variation to the Seller's quotation.

  At the Seller's sole discretion a deposit may be required.

  At the Seller's sole discretion:
  (a) payment shall be due on delivery of the Goods; or
  (b) payment for approved Buyers shall be made by instalments in accordance with the Seller's payment schedule.

  Time for payment for the Goods shall be of the essence and will be stated on the invoice or any other forms. If no

The production of these terms and conditions by the Seller is sufficient evidence of the Seller's rights to receive the insurance proceeds without the need for any person dealing with the Seller to make further enquiries.

# Buyer's Disclaimer

The Buyer hereby disclaims any right to rescind, or cancel any contract with the Seller or to sue for damages or to claim restitution arising out of any misrepresentation made to the Buyer by the S acknowledges that the Goods are bought relying solely upon the Buyer's skill and judgment. the Seller and the Buyer

- Defects
  The Buyer shall inspect the Goods on delivery and shall within forty eight (48) hours of delivery (time being of the essence) notify the Seller of any alleged defect, shortage in quantity, damage or failure to comply with the description or quote. The Buyer shall afford the Seller an opportunity to inspect the Goods within a reasonable time following delivery if the Buyer shall fail to comply with these provisions the Goods shall be presumed to be free from any defect or damage. For defective Goods, which the Seller has agreed in writing that the Buyer is entitled to reject, the Seller's liability is limited to either (at the Seller's discretion) replacing the Goods or repairing the Goods, except where the Buyer has acquired Goods as a consumer within the meaning of the Trade Practices Act 1974 (CVIIIty) or the Fair Trading Acts of the relevant state or territories of Australia, and is therefore also entitled to, at the consumer's discretion either a refund of the purchase price of the Goods, or repair of the Goods, or repair of the Goods. - Intellectual Property
  Where the Seller has designed, drawn or written Goods for the Buyer, then the copyright in those designs and drawinns and documents shall remain vested in the Seller, and shall only be used by the Buyer at the Seller's
- discretion.

  The Buyer warrants that all designs or instructions to the Seller will not cause the Seller to infringe any patent, registered design or trademark in the execution of the Buyer's order and the Buyer agrees to indemnify the Seller against any action taken by a third party against the Seller in respect of any such infringement.

  Drawings, sketches, painting, photographs, designs or typesetting furnished by the Seller, dummies, models or the like devices made or procured and manipulated by the Seller and negatives, positives, blocks, engravings, stencils, dies, plates or cylinders made from the Seller's original design, or from a design furnished by the Buyer, remain the exclusive property of the Seller unless otherwise agreed upon in writing. Sketches and dummies submitted by the Seller on a speculative basis shall remain the property of the Seller. They shall not be used for any purpose other than that nominated by the Seller and no ideas obtained there from any be used without the consent of the Seller. The Seller shall be entitled to compensation from the Buyer for any unauthorised use of such sketches and dummies.

  Disks, artwork and film supplied by the Buyer and/or other authorised persons remain the property of the Buyer. Unless otherwise indicated in writing the Seller shall assume these disks, artwork and film to be duplicate copies of the original.

### Default & Consequences of Default

- Default & Consequences of Default
  Interest on overdue invoices shall accrue daily from the date when payment becomes due, until the date of payment, at a rate of two and one half percent (2.5%) per calendar month and such interest shall compound monthly at such a rate after as well as before any judgment.

  If the Buyer defaults in payment of any invoice when due, the Buyer shall indemnify the Seller from and against all costs and disbursements incurred by the Seller in pursuing the debt including legal costs on a solicitor and own client basis and the Seller's collection agency costs.

  Without prejudice to any other remedies the Seller may have, if at any time the Buyer is in breach of any obligation (including those relating to payment), the Seller may suspend or terminate the supply of Goods to the Buyer and any of its other obligations under the terms and conditions. The Seller will not be liable to the Buyer for any loss or damage the Buyer suffers because the Seller has exercised its rights under this clause. If any account remains overdue after thirty (30) days then an amount of the greater of twenty dollars (\$20.00) or ten percent (10.0%) of the amount overdue (up to a maximum of two hundred dollars (\$200.00)) shall be levied for administration fees which sum shall become immediately due and payable.

  Without prejudice to the Seller's other remedies at law the Seller shall be entitled to cancel all or any part of any order of the Buyer which remains unfulfilled and all amounts owing to the Seller shall, whether or not due for payment, become immediately payable in the event that:

  (a) any money payable to the Seller's becomes soverdue, or in the Seller's opinion the Buyer will be unable to meet its payments as they fall due, or
- - Its payments as triey rail due, or (b) the Buyer becomes insolvent, convenes a meeting with its creditors or proposes or enters into an arrangement with creditors, or makes an assignment for the benefit of its creditors; or (c) a receiver, manager, liquidator (provisional or otherwise) or similar person is appointed in respect of the Buyer
  - or any asset of the Buyer.

- Security And Charge
  Despite anything to the contrary contained herein or any other rights which the Seller may have howsoever:

  (a) where the Buyer and/or the Guarantor (if any) is the owner of land, realty or any other asset capable of being charged, both the Buyer and/or the Guarantor agree to mortgage and/or charge all of their joint and/or several interest in the said land, realty or any other asset to the Seller or the Seller's nominee to secure all amounts and other monetary obligations payable under these terms and conditions. The Buyer and/or the Guarantor acknowledge and agree that the Seller (or the Seller's nominee) shall be entitled to lodge where appropriate a caveat, which caveat shall be withdrawn once all payments and other monetary obligations payable hereunder have been met.

- The Seller may cancel any contract to which these terms and conditions apply or cancel delivery of Goods at any time before the Goods are delivered by giving written notice to the Buyer. On giving such notice the Seller shall repay to the Buyer any sums paid in respect of the Price. The Seller shall not be liable for any loss or damage whatever arising from such cancellation.

- When quotations are based on specifications, roughs, layouts, samples or dummies or printed, typewritten or

- When quotations are based on specifications, roughs, layouts, samples or dummies or printed, typewritten or other good copy, any extra work or cost caused by any variation by the Buyer of his original instructions or by the manuscript copy being, in the Sellers opinion, poorly prepared or by the Buyer's requirements being different from those originally submitted for described may be charged to the Buyer and shown as extras on the invoice. All work carried out whether experimentally or otherwise at the Buyer's request will be charged to the Buyer. Any tabulated work and/or foreign language included in the job but not contained in the manuscript originally submitted for the purpose of estimating may be charged to the Buyer and shown as extras on the invoice. All extra work caused by author's corrections including resetting and/or the over-running of composition may be charged to the Buyer and shown as extras on the invoice. Unless otherwise agreed, the Buyer shall bear the cost of fonts, or colour proofs, or artwork, specially bought at his request for his work.
